TEMPORARY CLOSURE OF D6071 OLD GATED ROAD, CHESTERTON

TEMPORARY CLOSURE OF SHUCKBURGH

ROAD, PRIORS MARSTON Warwickshire County Council proposes to make Temporary Traffic Order closing Shuckburgh Road, Priors Marston, from a point opposite "Norwind," to vehicular traffic. The closure is required to safely

TEMPORARY CLOSURE OF HAMBRIDGE ROAD, BISHOPS ITCHINGTON

Warwickshire County Council has made a Temporary Traffic Order closing Hambridge Road, Bishops Itchington from points approximately 20 metres either side of the railway bridge, to vehicular traffic. The closure is required for safely facilitate a tactile examination of the bridge.
