ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF HOWCOMBE LANE, POPLAR ROAD, SCHOOL HILL AND THE BUTTS, NAPTON ON THE HILL

Warwickshire County Council proposes to make a Temporary Traffic Order closing Howcombe Lane, Poplar Road, School Hill and The Butts, Napton on the Hill to vehicular traffic as indicated below:

Howcombe Lane	From a point outside Malmsey Rise	11/10/19 - 16/10/19	Howcombe, Hollow Way, Poplar Road (and vice versa)
Poplar Road	From Jct. with The Butts to a point outside the sub-station	10/10/19 - 12/10/19	The Butts, Chapel Lane, High Street, New Street Howcombe Lane
School Hill	Rolling closure along their entire length	14/10/19	School Hill, Hackwell Street, High Street, New Street, Howcombe Lane, Poplar Road (and vice versa)
The Butts		- 25/10/19	

The closures are required for utilities undergrounding.

The Order will commence on 10 October 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 25 October 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

TEMPORARY CLOSURE OF D2412 WINDMILL LANE, LADBROKE, SOUTHAM

Warwickshire County Council proposes to make a Temporary Traffic Order closing D2412 Windmill Lane, Ladbroke, from its junction with the Southam Road, to vehicular traffic. The closure is required for carriageway patching and associated works, 08.00 - 16.00 daily.

The Order will commence on 7 October 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 10 October 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

Please note – Vehicular access and egress to Hedges Close will be restricted while works are in progress
