

ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

A423 MARTON ROAD/OXFORD ROAD, LONG ITCHINGTON

Order Effects: To impose a 40 mph Speed Restriction on A423 Oxford Road – from the central line of the Shakers Lane junction in a southerly direction for 50 yards AND on A423 Marton Road from the central line of the Shakers Lane junction in a northerly direction to the existing 30/50mph speed limit signs – effective 24 hours daily.

To close the road to all vehicular traffic from the 40 /50 mph speed limit signs to the junction with Shakers Lane.

Reason for Speed Restriction Order: for the safety of all road users due to raised iron works – effective 24 hours' daily.

Reason for Closure Order: carriageway resurfacing and associated works – overnight works 20.00hrs to 06.00hrs – roads will be open outside of these times.

Order Commences: 30 October 2019 for up to 18 months.

Anticipated Completion Date: 12 November 2019.

Access & Diversion: A423, A425, B4455 and vice versa.

VICARAGE ROAD, NAPTON

Order Effect: Road Closed to vehicular traffic from a point outside Bayntons Barn to outside Southview.

Reason for Order: for works to move an electricity pole.

Order Commences: 30 October 2019 for up to 18 months.

Anticipated Completion Date: 30 October 2019.

Access & Diversion: Butt Hill, Priors Marston Road, Dog Lane, High Street, Hackwell Street, Vicarage Road (and vice versa).

Warwickshire County Council proposes to make the following Temporary Traffic Orders:

C33 STOCKTON ROAD, STOCKTON, SOUTHAM

Order Effect: Road closed to vehicular traffic from its junction with Water Furrows to Millennium Way (entrance to Blue Lias Inn).

Reason for Order: Drainage works, 09.30 - 15.30 daily.

Order Commences: 11 November 2019 for up to 18 months.

Anticipated Completion: 15 November 2019.

Access & Diversion: A426 Southam Road, A423 Coventry Road, A423 Southam Road, Stockton Road and vice versa.

For all of the above temporary orders, pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.
