NOTICE OF MAKING AN ORDER

SECTION 119 HIGHWAYS ACT 1980

SM51 NAPTON-ON-THE-HILL (PART OF) PUBLIC PATH DIVERSION ORDER 2019

The above Order, made on 13 November 2019, under Section 119 of the Highways Act 1980, will **DIVERT** That section of Public Footpath SM51 from Point A, starting at the Old Bakery off High Street Napton-on-the-Hill (Grid Reference 446373 261078), running generally in a west south west direction for approximately 36 metres to Point B (Grid reference 446339 261062), at the rear of Viewlands Cottage, High Street, Napton-on-the-Hill, then running generally in a south westerly direction for 76 metres to Point C (Grid reference 446283 261018) **TO A LINE** from Point C running generally in a north easterly direction for approximately 70 metres to Point D (Grid reference 446329 261071), then running generally in a east north east direction for approximately 10 metres to Point E (Grid reference 446339 261076), then running generally in a north north east direction for approximately 20 metres to Point F (Grid Reference 446343 261091), then running generally in a south easterly direction for approximately 3 metres to Point G (Grid reference 446349 261089), then running generally in a north north east direction for approximately 8 metres to Point H (Grid reference 446352 261099), then running generally in a north easterly direction for approximately 8 metres to Point I (Grid reference 446360 261103) situated at the start of the driveway to Viewlands Cottage on the path between High Street and Chapel Lane. The new route shall have a width of 2 metres and a pedestrian gate shall be positioned between Points G and F as shown on the Order Plan.

A copy of the Order and Order Map may be seen free of charge at the Council Offices, Elizabeth House, Church Street, Stratford-upon-Avon between 8.45 a.m. to 5.15 p.m. Mondays to Wednesdays and 8.45 a.m to 5.00 p.m Thursdays to Fridays. Any representations about or objection to the Order may be sent in writing addressed to the Philip Grafton, Head of Governance and Democracy, Stratford-upon-Avon District Council, Elizabeth House, Church Street, Stratford-upon-Avon, Warwickshire CV37 6HX, not later than **NOON Friday 13 December 2019**. Please state the grounds on which it is made.

If no such representations or objections are duly made, or if any so made are withdrawn, Stratford-upon-Avon District Council may itself confirm the Order as an unopposed Order. If the Order is sent to the Secretary of State for confirmation, any representations or objections which have not been withdrawn will be sent with the Order.
