

ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

BASCOTE ROAD & PUDDING BAG LANE, SOUTHAM

Order Effect: Roads closed to vehicular traffic as follows:

13/04/20 – 24/04/20 Bascote Road closed from its junction with Welsh Road to the private drive leading to Bieloch and including the junction of Pudding Bag Lane,

20/04/20 – 10/05/20 Pudding Bag Lane closed from its junction with Bascote Road for a distance of approximately 30 metres.

Reason for Order: To facilitate works for the installation of a new electricity supply.

Order Commences: 13 April 2020 for up to 18 months.

Anticipated Completion: 10 May 2020.

Access & Diversion: Avoiding closure on Bascote Road – Welsh Road West, Welsh Road, Coventry Street, Coventry Road, Southam Road, The Green, Church Road, Bascote Road (and vice versa)

THE BUTTS, SCHOOL HILL, CHAPEL LANE, HOWCOMBE LANE & POPLAR ROAD, NAPTON ON THE HILL

Order Effects: Road closed to vehicular traffic as follows:

1. The Butts – from jct Poplar Road to point opposite jct Chapel Lane,
2. School Hill – from point opposite jct Chapel Lane to jct Hackwell Street,
3. Chapel Lane – from jct School Hill to 42m SE from jct School Hill,
4. Howcombe Lane – from jct The Butts to jct Hollow Way,
5. Poplar Road – from jct Howcombe Lane to jct The Butts.

Reason for Order: To facilitate phased works, rolling closures to enable the clearance of blockages on the BT Network.

Order Commences: 20 April 2020 for up to 18 months.

Anticipated Completion: 22 April 2020.

Access & Diversion: School Hill, Hackwell Street, High Street, New Street, Howcombe Lane and vice versa.

LADBROKE HILL LANE, LADBROKE

Order Effect: Road closed to vehicular traffic.

Reason for Order: To facilitate works for the installation of a marker post.

Order Commences: 21 April 2020 for up to 18 months.

Anticipated Completion: 23 April 2020.

SOUTHAM ROAD, PRIORS MARSTON

Order Effect: Road closed to vehicular traffic from a point adjacent to Marstons Meadows Farm.

Reason for Order: To facilitate works for the connection of a new clean water supply.

Order Commences: 18 April 2020 for up to 18 months.

Anticipated Completion: 19 April 2020.

Access & Diversion: Welsh Road, Priors Marston Road, Welsh Road East, Daventry Road, Southam Road, Butt Hill, Shuckburgh Road, The Holloway and vice versa.

For all of the above temporary orders, pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.
