## ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

### THE LOCKS, HILLMORTON

**Order Effect:** Road closed to vehicular traffic from a point opposite the Church entrance to the 3 Locks.

**Reason for Order:** To facilitate works for a new water connection.

**Order Commences:** 24 June 2020 for up to 18 months.

**Anticipated Completion:** 26 June 2020.

**Access & Diversion:** Access to Residents only by road plate.

**Contractor:** For Severn Trent Water, Gallaghers, Tel: 07880 034 069.

### MAIN STREET, HARBOROUGH MAGNA

**Order Effect:** Road closed to vehicular traffic.

**Reason for Order:** To facilitate works for the connection of a new water supply.

**Order Commences:** 25 June 2020 for up to 18 months.

**Anticipated Completion:** 27 June 2020.

**Access & Diversion:** Main Street, Easenhall Road, Rugby Road and vice versa.

### PUBLIC FOOTPATH R148 RYTON ON DUNSMORE

**Order Effect:** Public Footpath R148 Ryton on Dunsmore closed to all traffic from its junction with High Street (SP38625 74340) to the footpath on the A45 (SP38771 74354).

**Reason for Order:** To avoid the likelihood of danger to the public while development works are in progress near to the footpath.

**Order Commences:** 11 March 2019 and was due to expire 30 June 2020. However, the Secretary of State in exercise of his powers under Section 156(5) of the Road Traffic Regulation Act 1984 has directed that the Order shall continue in force until 30 June 2021, or until works are completed, whichever is the earlier (unless the Secretary of State issues a further direction).

**Access & Diversion:** Access to and egress from properties and land situated adjacent to the length of footpath to be closed, if any, will be maintained where possible.

### RUGBY ROAD (Service Road), DUNCHURCH

**Order Effect:** Road closed to vehicular traffic.

**Reason for Order:** To facilitate works for the installation of a boundary box.

**Order Commences:** 24 June 2020 for up to 18 months.

**Anticipated Completion:** 26 June 2020.

**Order Effect:** Road closed to vehicular traffic.

**Access & Diversion:** Church Hill, Fineacre Lane, Oxford Road, Freeboard Lane, Plott Lane, School Lane, Brookside and vice versa.

Access to frontages only.
