

ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

B4451 GAYDON ROAD/STATION ROAD, BISHOPS ITCHINGTON

Order Effect: Road closed to vehicular traffic from the roundabout at Plough Lane to its junction with Fisher Road.

Reason for Order: Carriageway resurfacing and associated works.

Order Commenced: 17 February 2020 for up to 18 months.

However, because of HS2 works these works had to be delayed. The work has now been rescheduled to commence 12 August 2020.

Anticipated Completion: 20 August 2020.

Access & Diversion: B4451 Gaydon Road, B4100 Banbury Road, B4455 Fosse Way, A425, Ufton Road, Deppers Bridge Road, B4451 Station Road and vice versa.

There will be no access or egress for vehicular traffic (within the works area) to roads adjoining Station Road/Gaydon Road whilst works are being carried out.

D6372 FISHER ROAD, BISHOPS ITCHINGTON

Order Effect: Road closed to vehicular traffic from its junction with Ladbroke Road to its junction with High Street.

Reason for Order: Carriageway patching and associated works, 09.00hrs-15.00hrs.

Order Commences: 10 August 2020 for up to 18 months.

Anticipated Completion: In one day on 10 August 2020.

Access & Diversion: Fisher Road, Chapel Street, Gaydon Road Fisher Road and vice versa.

C35 STONETON ROAD (STONETON LANE), PRIORS HARDWICK

Order Effect: Road closed to vehicular traffic from its junction with Marston Doles Road to Wormleighton Road/Church End.

Reason for Order: Drainage repairs and associated works, 09.30hrs-15.30hrs daily.

Order Commences: 24 August 2020 for up to 18 months.

Anticipated Completion: 28 August 2020.

LONG ITCHINGTON ROAD, LONG ITCHINGTON

Order Effect: Road closed to vehicular traffic from a point opposite the junction of Shakers Lane to a point outside the entrance to Top Farm.

Order Commences: 27 August 2020 for up to 18 months.

Anticipated Completion: 16 September 2020.

Access & Diversion: Long Itchington Road, Oxford Road, Station Road, Coventry Road, Birdingbury Road, Marton Road and vice versa.

SCHOOL STREET, STOCKTON

Order Effect: Road closed to vehicular traffic from the junction of The Square and Becks Lane.

Anticipated Completion: 2 September 2020.
