

## ROAD TRAFFIC REGULATION ACT 1984

**Warwickshire County Council has made the following Temporary Traffic Orders:**

### **BROADWELL ROAD, RUGBY**

**Order Effect:** Road closed to vehicular traffic from a point outside Grandborough Fields Farm.

**Reason for Order:** To facilitate works for a new connection.

**Order Commences:** 9 November 2020 for up to 18 months.

**Anticipated Completion:** 13 November 2020.

**Access & Diversion:** Broadwell Road, Flecknoe Station Road, Sawbridge Road, Willoughby Road, Grandborough Road, Hill Road, Southam Road, Flecknoe Road and vice versa.

### **DICKENS ROAD, RUGBY**

**Order Effect:** Road closed to vehicular traffic between the junctions with Norton Leys and Chaucer Road.

**Reason for Order:** Water mains replacement works and renewal of property service pipes.

**Order Commences:** 9 November 2020 for up to 18 months.

**Anticipated Completion:** 14 December 2020.

**Access & Diversion:** Norton Leys, Chaucer Road and vice versa.

### **SOUTHAM ROAD, DUNCHURCH**

**Order Effect:** Road closed to vehicular traffic between the junctions of Sandford Way and Toft Lane.

**Reason for Order:** Carriageway patching and associated works, 09.30hrs-15.30hrs.

**Order Commenced:** 14 August 2020 for up to 18 months. Unfortunately, works were delayed but have now been rescheduled to be completed between 09.30hrs & 15.30hrs on 11 November 2020.

**Access & Diversion:** Kingsley Avenue, Lower Hillmlorton Road, The Kent, School Street, Deerings Road, A428 and vice versa.

### **SPICER PLACE, RUGBY**

**Order Effect:** Road closed to vehicular traffic between its junction with Bilton Road and the north junction of Spice Place.

**Anticipated Completion:** In one day on 11 November 2020.
