ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

ASHLAWN ROAD, RUGBY

Order Effect: Road closed to vehicular traffic between A426/B4429 Cock Robin Roundabout junction and B4429 Ashlawn Road/Barby Road/Onley Lane junction in phases as follows: 8 January - 11 January, 15 January - 18 January, 16 April - 19 April and 23 April - 26 April.

Reason for Order: To enable Section 278 Highway works.

PARKFIELD ROAD, RUGBY – PROPOSED RELOCATION OF ROAD HUMPS
