ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

BECKS LANE, STOCKTON

Order Effect: Road closed to vehicular traffic.

Reason for Order: To enable works for a new domestic gas connection.

Order Commences: 7 January 2022 for up to 18 months.

Anticipated Completion: 7 January 2022.

Access & Diversion: St Michaels Crescent, Church Street, School Street, Becks Lane and vice versa.

THORNTONS LANE, NAPTON ON THE HILL

Order Effect: Road closed to vehicular traffic between Folly Lane and Brook End Farm.

Reason for Order: To enable renewal of existing water mains and associated works.

Anticipated Completion: 29 March 2022.

Access & Diversion: Thorntons Lane, Chapel Green Road, New Street, High Street, Hackwell Street, Vicarage Road, Butt Hill, Southam Road, Daventry Road, Welsh Road East, Holt Road, Napton Holt Road and vice versa.
