ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

D6044 HIGH STREET, D6046 CHURCH TERRACE, D6045 CHURCH STREET, D6048 HALL LANE & D6056 IVY LANE, HARBURY

Order Effect: Roads closed to vehicular traffic as follows: **High Street** between Mill Lane and Church Street, **Church Terrace** between Church Street and Bull Ring Farm Road, **Church Street** for a distance of 25 metres from its junction with High Street/Church Terrace, **Hall Lane** between Church Terrace and Crown Street and Ivy Lane for a distance of 50 metres from its junction with High Street.

Reason for Order: Carriageway resurfacing and associated works, 09.00hrs-15.30hrs.

Order Commences: 6 June 2022 for up to 18 months.

Anticipated Completion: 9 June 2022.

Access & Diversion: Crown Street, Vicarage Lane, South Parade, Park Lane, Temple End, Farm Street, Mill Street and vice versa. The One-way traffic flow in Ivy Lane will be temporarily suspended for access/egress for residents only.

Order Effect: Road closed to vehicular traffic between the B4451 Gaydon Road and Knightcote Road, Knightcote.

Reason for Order: Carriageway maintenance and associated works.

Order Commences: 6 June 2022 for up to 18 months.

Anticipated Completion: 10 June 2022.

Access & Diversion: B4451 Gaydon Road, Knightcote Road and vice versa.

STONEBRIDGE LANE, LONG ITCHINGTON

Order Effect: Road closed to vehicular traffic.

Anticipated Completion: 14 June 2022.

Access & Diversion: Stonebridge Lane, Church Road, Bascote Road, Welsh Road, Fosse Way, Long Itchington Road, Leamington Road and vice versa.

For all of the above temporary orders, pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.
