ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

B4451 GAYDON ROAD, BISHOPS ITCHINGTON

Order Effect: Road closed to vehicular traffic between its junctions with Plough Lane and Knightcote Bottoms.

Reason for Order: Carriageway patching and associated works, 09.30hrs-15.00hrs.

Order Commences: 19 December 2022 for up to 18 months.

Anticipated Completion: 20 December 2022.

Access & Diversion: B4451 Gaydon Road, B4100 Banbury Road, B4455 Fosse Way, A425 Southam Road, Ufton Road, Deppers Bridge Road, B4451 Station Road and vice versa. Access/Egress to/from adjoining roads may be restricted whilst works are in progress.

Order Effect: Road closed from junction of Southam Road to junction of Shuckburgh Road.

Reason for Order: To safely enable pole installation in carriageway.

Anticipated Completion: 21 December 2022.

Access & Diversion: Southam Road, Welsh Road, Welsh Road East, Holt Road, Shuckburgh Road, The Holloway and vice versa.

Access & Diversion: Blacksmiths Lane, Northend Road, Top Street, Malthouse Lane, Peartrees, Bottom Street and vice versa.
