

## ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

### DADGLOW ROAD, BISHOPS ITCHINGTON

**Order Effect:** Road closed to vehicular traffic between its junction with Starbold Road.
