### **DICK'S LANE, TURNER'S GREEN, ROWINGTON**

### **D51090 HIGH CROSS LANE, ROWINGTON**

**Order Effect:** Road closed to vehicular traffic between the junctions of The Cumsey and Holywell Lane.

### **NAPTON ROAD, STOCKTON**
