ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF COUGHTON FIELDS LANE, COUGHTON

Warwickshire County Council has made a Temporary Traffic Order closing Coughton Fields Lane, Coughton, from School Road to the A435 Birmingham Road, to vehicular traffic.

The closure is required for carriageway patching works.

The Order will commence on 9 March 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed in one day on 9 March 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Coughton Fields Lane, Captains Hill, Kinwarton Lane, Kinwarton Farm Road, Tything Road West, Arden Road, Birmingham Road and vice versa.

TEMPORARY CLOSURE OF HENLEY STREET AND CHURCH STREET, ALCESTER

Warwickshire County Council has made a Temporary Traffic Order closing Henley Street and Church Street, Alcester, from the junction with Swan Street to the junction with School Road, to vehicular traffic.

The closure is required for carriageway resurfacing.

The Order will commence on 6 March 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 13 March 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Swan Street, Priory Road, School Road, Kinwarton Road, Kinwarton Farm Road, Tything Road West, Arden Road, Birmingham Road and Vice Versa.

TEMPORARY CLOSURE OF FIELDS PARK DRIVE, ALCESTER
