ROAD TRAFFIC REGULATION ACT 1984, SECTION 14

TEMPORARY CLOSURE OF C215 WATERLOO ROAD, RYKNILD STREET & WIXFORD ROAD, BIDFORD ON AVON

Warwickshire County Council has made a Temporary Traffic Order closing C215 Waterloo Road, Ryknild Street & Wixford Road, Bidford on Avon, from Tower Hill to Dunnington Road, to vehicular traffic.

The closures are required to facilitate carriageway surface dressing works.

The Order will commence on 4 August 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 5 August 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Dunnington Road, Salford Road, Norton Road, Evesham Road, Station Road, Salford Road, Tower Hill and vice versa.

TEMPORARY CLOSURE OF ALNE HILLS, SHELFIELD GREEN

Warwickshire County Council has made a Temporary Traffic Order closing Newlands Lane, Shelfield Green at a point outside the property known as Newlands, to vehicular traffic.

The closure is required to facilitate works for the disconnection of an abandoned asset.

The Order will commence on 4 August 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 4 August 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Alne Hills, Shelfield Green, Burford Lane, Alcester Road, Henley Road, Village Road, Sernal Lane, Sernal Lane (and vice versa).

TEMPORARY CLOSURE OF D5432 ARDENS GRAFTON ROAD/TEMPLE GRAFTON ROAD, TEMPLE GRAFTON

Warwickshire County Council proposes to make a Temporary Traffic Order closing D5432 Ardens Grafton Road/Temple Grafton Road, Temple Grafton from Cox's Walk to New Road, to vehicular traffic.

The closure is required to safely facilitate footway improvement works.

The Order will commence on 14 August 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 31 August 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Temple Grafton Road, Bidford Road, Wixford Road, Evesham Road, Windmill Hill, New Road and vice versa.
