## ROAD TRAFFIC REGULATION ACT 1984. **SECTION 14 TEMPORARY CLOSURE OF C39**

SPERNAL LANE, SPERNALL

Warwickshire County Council has made a Temporary Traffic Order closing C39 Spernal Lane, Spernall at the river bridge, to vehicular traffic.

The closure is required to safely facilitate repairs to the bridge parapet.
