TEMPORARY CLOSURE OF SPERNAL LANE. GREAT ALNE

Warwickshire County Council has made a Temporary Traffic Order closing Spernal Lane, Great Alne, from a point adjacent to the property known as Appleby, to vehicular traffic.

The closure is required to facilitate works for the installation and connection of a new water supply.

The Order will commence on 11 June 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 15 June 2018.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: School Road, Captains Hill, Kinwarton Road, Kinwarton Farm Road, Arden Road, Birmingham Road, Coughton Hill, Haydon Way, Spernal Lane, Spernall Lane (and vice versa).

Any person who desires to question the validity of the Order or of any provision contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order may within six weeks from the date of the making of the Order apply to the High Court for this purpose.
