ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF ASPLEY HEATH LANE, ASPLEY HEATH

Warwickshire County Council proposes to make a Temporary Traffic Order closing Aspley Heath Lane, Aspley Heath from the junction with Broad Lane to the junction with Blind Lane, to vehicular traffic.

The closure is required to facilitate works for the renewal of a water main.

The Order will commence on 19 November 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 6 January 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Broad Lane, Blind Lane and vice versa.

TEMPORARY CLOSURE OF MANOR DRIVE, MORTON BAGOT

Warwickshire County Council proposes to make a Temporary Traffic Order closing Manor Drive, Morton Bagot from a point outside Morton Bagot Manor (between Spring Cottage and Orchard House), to vehicular traffic.

The closure is required to facilitate works for the renewal of a water pipe.

The Order will commence on 21 November 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 26 November 2018.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

TEMPORARY CLOSURE OF GREEN LANE, STUDLEY

Warwickshire County Council has made a Temporary Traffic Order closing Green Lane, Studley, from Brickyard Lane to Redditch Road, to vehicular traffic.

The closure is required to facilitate remedial carriageway works.

The Order will commence on 6 November 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 11 November 2018.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Green Lane, The Slough, Station Road, High Street, Redditch Road (and vice versa).
