

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF C204 BIRMINGHAM ROAD, ALCESTER

Warwickshire County Council has made a Temporary Traffic Order closing C204 Birmingham Road, Alcester from its junction with A435/B4089 Birmingham Road (Roebuck Island) its junction with School Road and Station Road, to vehicular traffic. The closure is required to facilitate structural patching works

The Order will commence on 15 January 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 16 January 2019.

PLEASE NOTE: It is anticipated that works will be carried out between 09.30hrs and 15.30hrs and the road will be open outside of these hours.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Priory Road, Swan Street Roundabout, Evesham Street, A435/A422 Evesham Road Island, A435 Alcester Bypass, A435 Birmingham Road (Roebuck Island) and vice versa.

TEMPORARY CLOSURE OF HAYE LANE, STUDLEY

TEMPORARY CLOSURE OF SEYMOUR ROAD, ALCESTER
