ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF MOORFIELD ROAD, ALCESTER

Warwickshire County Council proposes to make a Temporary Traffic Order closing Moorfield Road, Alcester between its junctions with School Road and Rectory Gardens, to vehicular traffic.

The closure is required to facilitate utility works.

The Order will commence on 26 February 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 28 February 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

TEMPORARY CLOSURE OF D5207 SAMBOURNE LANE, SAMBOURNE

Warwickshire County Council proposes to make a Temporary Traffic Order closing D5207 Sambourne Lane, Sambourne, from its junction with Oak Tree Lane to its junction with Jill Lane, to vehicular traffic.

The closure is required to facilitate carriageway patching and associated works

The Order will commence on 26 February 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed between 08.00hrs and 16.00hrs on 26 February 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.
