ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF C41 WOOD LANE, ASTON CANTLOW

Warwickshire County Council has made a Temporary Traffic Order closing C41 Wood Lane, Aston Cantlow, from its junction with Mill Lane to its junction with Billesley Road, to vehicular traffic. The closure is required to facilitate carriageway structural patching works.

The Order will commence on 29 March 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 30 March 2019.

PLEASE NOTE: It is anticipated that works will be carried out between 09.00 hrs and 15.00hrs and that the road will re-open outside of these hours.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.
