

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14

TEMPORARY CLOSURE OF PUBLIC FOOTPATH AL92 IN THE PARISH OF ASTON CANTLOW

Warwickshire County Council has made a Temporary Traffic Order closing Public Footpath AL92 in the Parish of Aston Cantlow, at Grid Reference SP13541-59619, to all traffic. The closure is required to avoid the likelihood of danger to the public because of the dangerous condition of the bridge along its route.

The Order will commence on 25 April 2019 and will last for a period of 6 months, or until remedial works are completed, whichever is the earlier.

Access to and egress from properties and land situated adjacent to the length of footpath to be closed, if any, will be maintained. **An alternative route is available and will be signed.**

TEMPORARY CLOSURE OF HARDWICK LANE, STUDLEY

Warwickshire County Council proposes to make a Temporary Traffic Order closing Hardwick Lane, Studley from a point adjacent to property number 1, to vehicular traffic. The closure is required to facilitate excavation works to enable installation of a new water main.

The Order will commence on 7 May 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 10 May 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Hardwick Lane, Castle Road, Alcester Road, Priory Square, Birmingham Road, Henley Road, Morton Bagot Road (and vice versa).

TEMPORARY CLOSURE OF EVESHAM ROAD, SALFORD PRIORS

Warwickshire County Council has made a Temporary Traffic Order closing Evesham Road, Salford Priors, from a point outside property number 7, to vehicular traffic. The closure is required to facilitate excavation works within the carriageway to enable the installation of water pipes for connection to the mains.

The Order will commence on 23 April 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 26 April 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Evesham Road, School Road, Salford Road, New Inn Lane (and vice versa).
