### ROAD TRAFFIC REGULATION ACT 1984 THE WARWICKSHIRE COUNTY COUNCIL (VARIOUS ROADS, GREAT ALNE) (RESTRICTED ROADS) (VARIATION 1) ORDER 2019

Warwickshire County Council has made the above Order under the Road Traffic Regulation Act 1984 the effect of which will extend the existing 30mph speed limit on the length of road mentioned in the Schedule below. The Order commences on 10 April 2019.

below. The Order confinences on 10 April 2019. A copy of the Order, together with a plan showing the length of road affected and a statement of the Council's reasons for making the Order, may be inspected at the Main Reception, Shire Hall, Marter Place, Warwick; at the Stratford on Avon District Council, Elizabeth House, Church Street, Stratford on Avon; and at Alcester Library and One Stop Shop, Globe House, Priory Road, Alcester B49 5DZ, during usual opening hours.

Any person who desires to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any instrument made under it has not been compiled with in relation to the Order may within six weeks from the date of the making of the Order apply to the High Court for this purpose.

## SCHEDULE

# Existing 30mph Speed Limit to be extended by 115 metres

Spernal Lane, Great Alne, from its junction with B4089 Alcester to Wootton Wawen Road, in a north-westerly direction for a distance of 365 metres (being an extension of 115 metres from the end of the current 30 mph speed limit).

#### ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF ST. ASAPHS AVENUE, STUDLEY

Warwickshire County Council proposes to make a Temporary Traffic Order closing St. Asaphs Avenue, Studley, from its junction with Corbizum Avenue to its junction with St. Judes Avenue, to vehicular traffic. The closure is required to facilitate utility works.

The Order will commence on 28 May 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 31 May 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible. An alternative route will be signed and is available via: St Asaphs Avenue, Corbizum Avenue, St Judes Avenue (and vice versa).
