confirmed the above Order. The effect of the Order as confirmed is to divert the public footpath known as Footpath No. BE-585(C)(Part).

Description of Existing Footpath BE-585(C) (Part) to be Diverted The section of Footpath BE-585(C), for its full width, commencing at Point A (OSGB 408212, 268096) within the central reservation of the Coventry Highway (A4023), and running generally in a north-

northeasterly direction for 336 metres, terminating at Point B (OSGB 408323, 268413), east of Hedera Road. Description of Proposed Diverted Route of

Footpath BE-585(C) (Part) Proposed Footpath commencing at Point C (OSGB 408345, 268500) east of Unit 9 Hedera Road.

connecting to existing Footpath BE-585(C), and then running in a north-westerly direction for 27 metres to Point D (OSGB 408323, 268516),

and then running in a south-westerly direction for 280 metres to Point E (OSGB 408148, 268298),

and then running in a south-westerly direction for 63 metres to Point F (OSGB 408108, 268249), at the

southern corner of Unit 10 Hedera Road, where it joins with the existing publicly maintained highway. The diverted route is 370 metres in length and

a width of 2 metres. A copy of the Order and map may be seen or obtained free of charge at the Reception, Town Hall, Walter Stranz Square, Redditch, Worcestershire between the hours of 9am - 5pm Monday to Friday. This Order comes into force on the date on which Redditch Borough Council certify that the terms of Article 2 of the order have been complied with. If any person aggrieved by the order desires to question its validity or that of any provision contained in it on the ground that it is not within the powers of the above Act, or on the ground that any

requirement of that Act or any regulation made under it has not been complied with in relation to

the confirmation of the order, he or she may apply

to the High Court for any of these purposes under section 287 of the Town and Country Planning Act 1990 within 6 weeks from the date on which notice
