

ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

COUGHTON FIELDS LANE, COUGHTON

Order Effect: Road closed to vehicular traffic from the junction with Stout Lane to a point outside property number 29.
