## ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

### PUBLIC FOOTPATH DRURY LANE, CALDECOTT

**Order Effect:** The Public Footpath will be closed to all traffic from a point opposite to property number 13.

**Reason for Order:** To facilitate works for a new water connection.

**Order Commences:** 20 May 2020 for up to 6 months.

**Anticipated Completion:** 21 May 2020.

**Access & Diversion:** Drury Lane, Wool Street, Sheep Street, Chapel Street and vice versa.

### NEWBOLD ROAD & HUNTERS LANE, RUGBY

**Order Effect:** Right Hand Turning from Newbold Road in to Hunters Lane will be prohibited.

Right Hand turning from Hunters Lane in to Newbold Road will be prohibited.

**Reason for Order:** To manage/alleviate congestion of traffic wishing to use the recycling centre, for the safety of all road users.

**Order Commences:** 23 May 2020 for up to 18 months.
