ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

COUGHTON FIELDS LANE, ALCESTER

Order Effect: Road closed to vehicular traffic from its junction with Captains Hill to a point outside Coughtonfields Farm.

Reason for Order: To facilitate cabling & splicing works and excavation of blockages.

Order Commences: 3 November 2020 for up to 18 months.

Anticipated Completion: 9 November 2020.

PUBLIC FOOTPATH AL199 IN THE PARISH OF MARCLIFF, BIDFORD ON AVON

Order Effect: Footpath closed to all traffic at Grid Reference SP10138-50812.
