

ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

GEORGE'S ELM LANE, BIDFORD ON AVON

Order Effect: Road closed to vehicular traffic between its junctions with Waterloo Road and Wixford Road.

Reason for Order: To enable works for a new water connection.

Order Commences: 24 February 2021 for up to 18 months.

Anticipated Completion: 26 February 2021.

Access & Diversion: George's Elm Lane, Wixford Road, Evesham Road, Stratford Road, Tower Hill, Waterloo Road, Ryknild Street and vice versa.

SURFACE DRESSING SOUTH WARWICKSHIRE 2021

Order Effect: Roads closed to vehicular traffic as indicated in the schedule below, in addition a 10mph speed restriction will be imposed for safety of road users and contractors should access be required.

WOOD LANE, HASELOR

Order Effect: Road closed to vehicular traffic from a point outside Haselor Grounds heading northwards for approximately 95 metres.

Reason for Order: To enable works for the installation of poly duct in the carriageway.

Order Commences: 9 March 2021 for up to 18 months.

Anticipated Completion: 22 March 2021.

Access & Diversion: Wood Lane, Pelham Lane, Henley Road, Alcester Road, Whitehouse Hill, Bearley Road, Pear Tree Gardens, Burbage Road, Brook Road, Wilmcote Lane, Billesley Road and vice versa.
