The sale of alcohol for consumption on or away from the premises between the hours of: 12noon and 00:00 (midnight) Monday -Thursday; 12noon until 01:00am Friday - Saturday; 12noon until 23:00pm Sunday

With the exceptions being on Christmas Eve and New Years Eve where hours will be extended until 01:00am

Late night Refreshment will be provided - Monday to Thursday 23:00 00:00 Friday & Saturday 23:00

01:00am Christmas Eve and New Year's Eve: 23:00-01:00

Alongside the sale of alcohol, The provision of recorded music will be provided between the hours of 07:30am and 00:00 Monday-Thursday, 07:30am - 01:00am Friday Saturday, 07:30am -23:00 on Sundays, on Christmas Eve and New Years Eve this will be 07:30am - 01:00am.

The playing of recorded music and radio will occur on the premises but never be amplified past 23:00hours in line with noise pollution regulations, where amplified up until this hour noise levels will never exceed the maximum allowance for residential areas to not disturb the peace of those in nearby residential areas.

All staff employed with the company will be fully trained in weights and measures and how to identify and questions those who appear under the age of 25; Challenge 25 posters will be clearly displayed in public view as well as a signed list of those trained on the service of alcohol. Employees working behind the bar will all be a minimum of 18 years of age.
