

## ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

### SPERNAL LANE, STUDLEY

**Order Effect:** Road closed to vehicular traffic from a point outside The Old Rectory for a distance of approximately 850 metres.

**Reason for Order:** To safely enable works on telegraph poles.

**Order Commences:** 6 July 2021 for up to 18 months.

**Anticipated Completion:** 6 July 2021.

**Access & Diversion:** Spernal Lane, Spernal Lane, School Road, Captains Hill, Kinwarton Road, Kinwarton Farm Road, Tything Road West, Arden Road, Birmingham Road, Coughton Hill, Haydon Way and vice versa.

Warwickshire County Council proposes to make the following Temporary Traffic Orders:

### D5180 NEW ROAD & D5201 NEEDLE CLOSE, STUDLEY

**Order Effect:** New Road closed to vehicular traffic between its junction with the A435 Alcester Road and Westmead Avenue and Needle Close from its junction with A435 Alcester Road.

**Reason for Order:** Carriageway patching and associated works.

**Order Commences:** 26 July 2021 for up to 18 months.

**Anticipated Completion:** 27 July 2021.

**Access & Diversion:** A435 Alcester Road, Toms Town Lane, New Road and vice versa.

No diversion available for Needle Close, access/egress will be maintained where possible to businesses and residents only.

### SPERNAL LANE, GREAT ALNE

**Order Effect:** Road closed to vehicular traffic between its junctions with Stoot Lane and Nightingale Close.

**Anticipated Completion:** 21 July 2021.

**Access & Diversion:** Spernal Lane, School Road, Captains Hill, Kinwarton Road, Kinwarton Farm Road, Tything Road West, Arden Road, Birmingham Road, Coughton Hill, Haydon Way, Spernal Lane and vice versa.

### THE WARWICKSHIRE COUNTY COUNCIL (A435 GORCOTT HILL, STRATFORD DISTRICT) (50MPH SPEED LIMIT) ORDER 2021

Warwickshire County Council has made the above named Order under the Road Traffic Regulation Act 1984, the effect of which will be to impose a 50mph speed limit on the length of road mentioned in the Schedule below. The Order commences on 5 July 2021.

Any person who desires to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order may within six weeks from the date of the making of the Order apply to the High Court for this purpose.

### SCHEDULE

A435 Gorcott Hill – Existing NSL70 to become 50mph

- (i) From the existing 40mph/National Speed Limit terminal point on the A435 south of the A4023, in a north easterly direction along the A435 northbound carriageway of Gorcott Hill for a distance of 450m.
- (ii) From the existing 40mph/National Speed Limit terminal point on the A435 south of the A4023, in a north easterly direction along the A435 southbound carriageway of Gorcott Hill for a distance of 450m.
