

## ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

### **ARDENS GRAFTON ROAD, TEMPLE GRAFTON**

**Order Effect:** Road closed to vehicular traffic from Church Bank eastwards to a point outside Greenways.

**Reason for Order:** To safely enable pole testing and vegetation cutting around poles.

**Order Commences:** 19 October 2021 for up to 18 months.

**Anticipated Completion:** 19 October 2021.

**Access & Diversion:** Temple Grafton Road, Bidford Road, Wixford Road, Evesham Road, Windmill Hill, New Road and vice versa.
