ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

FORK HILL, SPERNAL

Order Effect: Road closed to vehicular traffic.

Reason for Order: To enable installation of a small hydrant cut out.

Order Commences: 5 January 2022 for up to 18 months.

Anticipated Completion: 7 January 2022.

Access & Diversion: Fork Hill, Spernal Lane, Spernal Lane, Village Road, Alne End, Henley Road, Alcester Road, Wootton Rise, Stratford Road, Mayswood Road, Mays Hill, Hunger Hill, Oldberrow Lane, Morton Bagot Road and vice versa.

MEETING LANE, ALCESTER

Order Effect: Road closed to vehicular traffic from its junction with Henley Street.

Access & Diversion: Residential, commercial & pedestrian access will be maintained at all times.

Access & Diversion: New Road, Alcester Road, Toms Town Lane and vice versa.
