ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

D5153 MANOR ROAD, STUDLEY

Order Effect: Road closed to vehicular traffic between its junctions with A435 Alcester Road and Albury Road.

Reason for Order: Carriageway patching and associated works, 08.00hrs-16.00hrs.

Order Commences: 1 March 2022 for up to 18 months.

Anticipated Completion: 1 March 2022.
