

## ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

### **A435 BIRMINGHAM ROAD/GORCOTT HILL NORTH & A4023 COVENTRY HIGHWAY EASTBOUND/A435 NORTHBOUND SLIP, MAPPLEBOROUGH GREEN**

**Order Effect:** Roads closed to vehicular traffic as follows: **A435 Birmingham Road/Gorcott Hill North (Northbound Carriageway only)** – closed between the A435/A4189 Roundabout (Dog Island), to County Boundary, **A4023 Coventry Highway Eastbound/A435 Northbound Slip** – closed between the entrance to Amazon and the A435.

**In addition, a Temporary 40 mph Speed Limit will be imposed** on **A4023** from a point outside Amazon to the junction with A435, and on **A435 (Northbound Carriageway)** from the entrance to Northbound Slip(A4023) de-restricted sign to County Boundary, to vehicular traffic.

**Reason for Order:** Closed to enable carriageway resurfacing and associated works – overnight weeknights only 20.00hrs-06.00hrs. Speed Limit required for the safety of all road users and workforce during times when the road is open.

**Order Commences:** 3 October 2022 for up to 18 months.

**Anticipated Completion:** 13 October 2022.

**Access & Diversion:** One Way Diversion: A4023 Coventry Highway, A435 (Southbound), A4189 Warwick Highway, Alders Drive, A4023, A441, B4101, A435.

### **D5211 SAMBOURNE LANE, COUGHTON**

**Order Effect:** Road closed to vehicular traffic between its junction with the A435 Birmingham Road and the entrance to Coughton Lodge Farm.

**Reason for Order:** Footway reconstruction, kerb replacement and associated works, 09.30hrs-15.30hrs.

**Order Commences:** 3 October 2022 for up to 18 months.

**Anticipated Completion:** 7 October 2022.

**Access & Diversion:** Sambourne Lane, Wike Lane, Middletown Lane, A448 Bromsgrove Road, A435 (Haydon Way, Birmingham Road) and vice versa.

**Anticipated Completion:** 17 October 2022.
