## ROAD TRAFFIC REGULATION ACT 1984

**Warwickshire County Council has made the following Temporary Traffic Orders:**

### **B4085 CLEEVE ROAD, MARLCLIFF**

**Order Effect:** Road Closure, between its junction with Honeybourne Road and The Bank.

**Reason for Order:** Footway reconstruction works, closed 09.30hrs-15.30hrs, weekdays only.

**Order Commences:** 4 September 2023 for up to 18 months.
