# HILLMORTON LANE (THE KENT) RUGBY

Warwickshire County Council has made a Temporary Traffic Order closing C30 Hillmorton Lane (The Kent) Rugby for a distance of approximately 20 metres either side of the railway bridge, to vehicular traffic.

The closure is required to facilitate a safety examination of the railway bridge.

## TEMPORARY CLOSURE OF C28
