ROAD TRAFFIC REGULATION ACT 1984, SECTION 14

TEMPORARY CLOSURE OF C28 BRETTFORD ROAD, KING'S NEWNHAM

Warwickshire County Council has made a Temporary Traffic Order closing C28 Brettford Road, King's Newnham from the junction with Kings Newnham Lane to Newnham Lane, to vehicular traffic.

The closure is required for carriageway patching.

The Order will commence on 8 February 2016 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 10 February 2016.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: B4455 Fosse Way, Kings Newnham Lane and vice versa.

TEMPORARY CLOSURE OF D3182 CHURCH WALK, RUGBY

Warwickshire County Council has made a Temporary Traffic Order closing D3182 Church Walk, Rugby to vehicular traffic.

The closure is required to facilitate a water service cut off.

The Order will commence on 12 February 2016 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed in one day on 12 February 2016.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

TEMPORARY CLOSURE OF D2182 CHURCH HILL, STRETTON ON DUNSMORE

Warwickshire County Council proposes to make a Temporary Traffic Order closing D2182 Church Hill, Stretton on Dunsmore from Brookside roundabout to a point outside the Meeting Hall, to vehicular traffic.

The closure is required to facilitate the installation of a new gas service.

The Order will commence on 15 February 2016 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 18 February 2016.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: D2188 Fineacre Lane, A423 Oxford Road, D2128 Freeboard Lane, D2176 Plott Lane, D2177 School Lane (and vice versa).
