

**ROAD TRAFFIC REGULATION ACT 1984 –

THE A5 TRUNK ROAD (GIBBET HILL  
ROUNDAABOUT, LUTTERWORTH)  
(TEMPORARY PROHIBITION OF TRAFFIC)  
ORDER 2016**

NOTICE IS HEREBY GIVEN that Highways England Company Limited (Company No. 9346363) has made an Order on the A5 Trunk Road at Lutterworth, in the County of Leicestershire, to allow pavement reconstruction works to be carried out.

The effect of the Order will be to -

- a) Close lengths of the circulatory carriageway at the roundabout junction of the A5 with the A426 and Gibbet Lane (Known as Gibbet Hill Roundabout); and
- b) prohibit vehicles from entering or leaving Gibbet Hill Roundabout to or from the A426 or Gibbet Lane at its junction with –
  - i) A426 Gibbet Hill;
  - ii) A426 Rugby Road; or
  - iii) Gibbet Lane.

The work will be carried out over two weekends between 20:00 hours on Friday and 06:00 hours on Monday and is expected to start on Friday 19 February 2016, and will continue on Friday 26 February 2016. The Order will come into force on 12 February 2016.

Vehicles being used for police, fire brigade or ambulance purposes and vehicles being used in connection with the works or by a traffic officer, will be exempt from the closures.

A5 traffic will be controlled at the roundabout by temporary 2-way traffic signals. Diversion routes for the A426 and Gibbet Lane will be signed.

(TEMPORARY PROHIBITION OF TRAFFIC)  
ORDER 2016**

NOTICE IS HEREBY GIVEN that Highways England Company Limited (Company No. 9346363) intends to make an Order on the A45 Trunk Road, southwest of Rugby, in the County of Warwickshire, to allow sign replacement works to be carried out.

The effect of the Order will be to close the slip road leading from the southbound carriageway of the A45 to the A4071.

The work will be carried out overnight between 20:00 hours and 05:00 hours and is expected to start on Tuesday 8 March 2016 and continue for two nights. The Order will come into force on 1 March 2016.

Vehicles being used for police, fire brigade or ambulance purposes and vehicles being used in connection with the works, will be exempt from the closure.

A diversion route via the A45/B4429/M45 roundabout junction will be signed.
