ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF THE LOCKS, RUGBY

Warwickshire County Council proposes to make a Temporary Traffic Order closing The Locks, Rugby to vehicular traffic.

The closure is required to safely facilitate essential bridge examination.

The Order will commence on 23 April 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 23 April 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Brindley Road, The Locks, Hillmorton Locks Lane, Watling Street, A5 from end of dualling east of Newton to jct A5 Spur Roundabout, Lilbourne Road, Hillmorton Lane, The Kent (and vice versa).

TEMPORARY CLOSURE OF C88 BILTON LANE, CHURCH LAWFORD, RUGBY

Warwickshire County Council proposes to make a Temporary Traffic Order closing C88 Bilton Lane, Church Lawford, Rugby from the junction with A4071 Rugby Western Relief Road to the junction with Lawford Lane, to vehicular traffic.

The closure is required for carriageway resurfacing works. The Order will commence on 28 April 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 4 May 2017.

Please Note: The works will be carried out between 09.30hrs and 15.50hrs daily.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: A4071 Rugby Western Relief Road, B4642 Coventry Road, Lawford Lane, Bilton Lane and vice versa.
