

## ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF D3585 BEECH DRIVE, RUGBY

Warwickshire County Council made a Temporary Traffic Order closing D3585 Beech Drive, Rugby to vehicular traffic.

The closure was required for carriageway resurfacing works.

The Order commenced on 21 February 2017 for a period of 18 months, or until the works were completed, whichever was the earlier; unfortunately the works did not go ahead as planned. However the works have now been rescheduled to commence 25 April 2017 with anticipation of completion on or before 28 April 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

## TEMPORARY CLOSURE OF PUBLIC FOOTPATH R54 IN THE PARISH OF MONKS KIRBY

Warwickshire County Council has made a Temporary Traffic Order closing Public Footpath R54 in the Parish of Monks Kirby from grid reference SP4528 8457 (Fosse Way) to grid reference SP4627 8315 (Millers Lane), to all traffic.

The closure is required to avoid the likelihood of danger to the public as a result of one collapsed bridge and a second dangerous dilapidated bridge along its route.

The Order will commence on 15 April 2017 and will last for a period of 6 months, or until remedial works are completed, whichever is the earlier.

Access to and egress from properties and land situated adjacent to the length of footpath to be closed, if any, will be maintained where possible.

An alternative route will be signed and is available via: Fosse Way, Millers Lane.

## TEMPORARY CLOSURE OF PUBLIC FOOTPATH R129 IN THE PARISH OF LONG LAWFORD

Warwickshire County Council made a Temporary Traffic Order closing Public Footpath R129 in the Parish of Long Lawford, between Grid References 447126.275594 and 447222.275787, to all traffic.

The closure was required to avoid danger to persons using the path, or preventing the likelihood of such danger, arising from nearby development works.

The Order commenced on 22 October 2016 for a period of 6 months, or until the works were completed, whichever was the earlier. The Secretary of State in exercise of his powers under Section 15(5) of the Road Traffic Regulation Act 1984 has now directed that the Order should continue in force until the works to which it relates have been completed or until 22 April 2019, whichever is the earlier (unless the Secretary of State extends the Order by a further direction).

Access to and egress from properties and land situated adjacent to the length of footpath to be closed will be maintained.

An alternative route will be signed and is available via: A428 Coventry Road, The Green, Railway Street, and Back Lane.

## TEMPORARY CLOSURE OF B4109 TEMPLE HILL, WOLVEY HEATH, RUGBY
