

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF SIDNEY ROAD, RUGBY

Warwickshire County Council has made a Temporary Traffic Order closing Sidney Road, Rugby from a point outside property number 85, to vehicular traffic. The closure is required to facilitate works for the installation of a comm pipe.

The Order will commence on 17 July 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 19 July 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Sidney Road, Percival Road, Oval Road (and vice versa).

TEMPORARY CLOSURE OF B4642 COVENTRY ROAD, CAWSTON

Warwickshire County Council has made a Temporary Traffic Order closing B4642 Coventry Road, Cawston from the existing roundabout (outside Lowood) and for a distance of approximately 100 metres either side of the new access bellmouth, to vehicular traffic.

The closure is required to facilitate the laying of new carriageway surfacing.

The Order will commence on 15 July 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 16 July 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Coventry Road, Rugby Western Relief Road, Blue Boar Flyover, Rugby Road, London Road, A45 From jct A4071/B4453 to jct M45/B4429 E, A45 jct M45/B4429 Roundabout, Northampton Lane, Alwyn Road (and vice versa).

TEMPORARY CLOSURE OF BROCKHURST LANE, MONKS KIRBY

The closure is required to facilitate carriageway resurfacing works.

TEMPORARY 10 MPH SPEED LIMIT A4071 RUGBY WESTERN RELIEF ROAD, RUGBY
