

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF D2172 MAIN STREET, BOURTON ON DUNSMORE, RUGBY

Warwickshire County Council has made a Temporary Traffic Order closing D2172 Main Street, Bourton on Dunsmore, Rugby from the junction with Frankton Lane to the junction with Draycote Road, to vehicular traffic.

The closure is required to facilitate carriageway patching works.

The Order will commence on 23 October 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed in one day on 23 October 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Bourton Lane, Birdingbury Road, Frankton Road, Main Street, Marton Road, Birdingbury Road, A423 Oxford Road, B4453 Rugby Road, B4453 Princethorpe Road, Main Street and vice versa.

TEMPORARY CLOSURE OF FOSSE WAY, STRETTON UNDER FOSSE
