Notice is hereby given ON BEHALF OF THE SECRETARY OF STATE AND HIS INSPECTOR under the above Regulations that the following "further information" relating to the Environmental Statement has been submitted **to the Secretary of State by the appellant** as part of the above Planning Appeal.

Full Planning Permission is sought for:

"Proposed development of an up to 12MWp ground mounted solar PV park comprising x2 substations, electrical cabins, storage cabinet, solar arrays, perimeter fencing and gates, CCTV, access tracks, new highway junction and associated landscaping."

An Appeal was submitted by Hive Energy Ltd (Ref: APP/E3715/W/17/3171976 – Start Date 15th June 2017) against the refusal of Application Ref: R13/1401 (submitted 4th November 2014) by Rugby Borough Council for the above proposed development.
