

## ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF SCHOOL STREET & RAILWAY STREET, LONG LAWFORD

Warwickshire County Council proposes to make a Temporary Traffic Order closing Long Street & Railway Street, Long Lawford as indicated in the schedule below, to vehicular traffic.

The closures are required for carriageway resurfacing.

The Order will commence on 21 May 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 23 May 2018.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

### TEMPORARY CLOSURE OF COPSTON LANE, COPSTON MAGNA

Warwickshire County Council has made a Temporary Traffic Order closing Copston Lane, Copston Magna from the junction with Green Lane to the junction with Cloudesley Bush Lane, to vehicular traffic.

The closure is required to facilitate works for the installation of a power duct.

The Order will commence on 8 May 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 21 May 2018.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Copston Lane, Cloudesley Bush Lane, Lutterworth Road, Smockington Lane, A5 from jct B4114 west of Smockington to start of dualling south of Smockington, Watling Street, A5 from start of dualling south of Smockington to jct B4455 Se, Coventry Road (and vice versa).

### TEMPORARY CLOSURE OF C34 BIRDINGBURY ROAD, FRANKTON, RUGBY

Warwickshire County Council proposes to make a Temporary Traffic Order closing C34 Birdingbury Road, Frankton, Rugby from the junction with Main Street to the junction with Bourton Lane, to vehicular traffic.

The closure is required to facilitate carriageway patching works.

The Order will commence on 21 May 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 25 May 2018.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Bourton Lane, Main Street, Frankton Road, Bourton Road, Main Street and vice versa.

### TEMPORARY CLOSURE OF CATHIRON LANE, HARBOROUGH MAGNA

Warwickshire County Council has made a Temporary Traffic Order closing Cathiron Lane, Harborough Magna from a point 60 metres from the property known as Frog Cottage to a point opposite Oak Lodge, to vehicular traffic.

The closure is required to safely facilitate works for the installation of a duct in the verge.

The Order will commence on 8 May 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 10 May 2018.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Cathiron Lane, Little Lawford Lane, Little Lawford Road, Bretford Road, Newnham Lane, Fosse Way, Rugby Road (and vice versa).
