

## ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14(1)(a) THE A5 TRUNK ROAD (MAGNA PARK ROUNDABOUT TO GIBBET HILL ROUNDABOUT) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2018

NOTICE IS HEREBY GIVEN that Highways England Company Limited

(Company No. 9346363) has made an order on the A5 Trunk Road, between Magna Park and Churchover in the Counties of Leicestershire and Warwickshire, to allow the upgrading of weather stations and an electronic traffic detection system to be installed.

The effect of the Order will be to close -

- a) the southbound carriageway of the A5 between its roundabout junction with the A4303. the B4027 and Coal Pit Lane, at Magna Park, and its roundabout junction with the A426 Gibbet Hill and Gibbet Lane, near Churchover; and
- b) any layby located adjacent to the length of the A5 described in a) above.

The work is expected to start on Monday 22 October 2018 and continue for two nights. The layby closures will be in operation from 14:00 hours on Monday 22 October 2018 for 24 hours per day for the duration of the works. The carriageway closure will be carried out overnight between 22:00 hours and 06:00 hours and is expected to start on Thursday 1 November 2018 and continue for two nights. The Order will come into force on 21 October 2018.

Vehicles being used for police, fire and rescue authority or ambulance purposes, and vehicles being used in connection with the works will be exempt from the closures.

(TEMPORARY RESTRICTION AND PROHIBITION OF TRAFFIC) ORDER 2018 NOTICE IS HEREBY GIVEN that Highways England Company Limited (Company No. 9346363) intends to make an order on the A5 Trunk Road, between Magna Park and High Cross in the County of Leicestershire, to allow a road widening and roundabout construction works to be carried out.

The effect of the Order will be to -

(1) impose a 40 miles per hour speed restriction on -

Woodway Lane near Wibtoft: and

- the southbound carriageway of the A5 from a point 560 metres north of the centreline of its junction with Woodway Lane, near Wibtoft, to its roundabout junction with the A4303, Coal Pit Lane and the B4027 at Lutterworth; and
- ii) the northbound carriageway of the A5 from its roundabout junction with the A4303, Coal Pit Lane and the B4027 at Lutterworth to a point 200 metres north of the centreline of its junction with High Cross Road at High Cross;
- (2) impose a 50 miles per hour speed restriction on the southbound carriageway of the A5 from a point 200 metres north of the centreline of its junction with High Cross Road at High Cross, to a point 560 metres north of the centreline of its junction with Woodway

the closures and prohibitions.

- Lane near Wibtoft; and (3) close the northbound carriageway of the A5 from its roundabout junction with the A4303, Coal Pit Lane and the B4027 at Lutterworth, to the centreline of its junction with
  - ii) the southbound carriageway of the A5 from its roundabout junction with the slip roads leading to and from the M69 at Junction 1, to its roundabout junction with the A4303, Coal Pit Lane and the B4027 at Lutterworth;
- (4) prohibit any vehicle with a width exceeding 3.25 metres from entering or proceeding on the A5 between its roundabout junction with the A4303, Coal Pit Lane and the B4027 at
- Lutterworth and the junction with High Cross Road; and (5) prohibit any vehicle from entering or leaving the A5 at its junction with Mere Lane at
- Lutterworth. The work is expected to start on Monday 5 November 2018 and continue for 12 months.

The carriageway closures will be carried out overnight between 20:00 hours and 06:00 hours. The speed restriction, width restriction and side road access restriction will be in operation for 24 hours per day, starting at 20:00 hours on Monday 5 November 2018 and will continue for the duration of the works. The Order will come into force on 2 November 2018.

Vehicles being used for police, fire and rescue authority or ambulance purposes will be exempt from the speed restrictions, closures and prohibitions. Vehicles being used for special forces purposes will be exempt from the speed restrictions, and vehicles being used in connection with the works or for winter maintenance purposes will be exempt from
