

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF PAILTON ROAD & RUGBY ROAD, HARBOROUGH MAGNA

Warwickshire County Council has made a Temporary Traffic Order closing Pailton Road & Rugby Road, Harborough Magna from the junction of Easenhall Road and Rugby Road to the junction of Pailton Road and Back Lane, to vehicular traffic.

The closure is required to facilitate carriageway patching works.

The Order will commence on 19 November 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 20 November 2018.

PLEASE NOTE: The works will be carried out between 09.30hrs and 15.30hrs daily. Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

TEMPORARY CLOSURE OF B4428 COVENTRY ROAD & WITHYBROOK ROAD, PAILTON

Warwickshire County Council proposes to make a Temporary Traffic Order closing B4428 Coventry Road & Withybrook Road, Pailton from the junction with the Fosse Way to the junction of Rugby Road, to vehicular traffic.

The closure is required to facilitate carriageway resurfacing works.

The Order will commence on 3 December 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 5 December 2018.

PLEASE NOTE: The works will be carried out between 09.00hrs and 15.00hrs. Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

TEMPORARY CLOSURE OF LAWFORD ROAD, RUGBY

Warwickshire County Council proposes to make a Temporary Traffic Order closing Lawford Road, Rugby to vehicular traffic.
