#### ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF MAIN STREET, WOLSTON

Warwickshire County Council proposes to make a Temporary Traffic Order closing Main Street, Wolston from Rugby Road to School Street, to vehicular traffic.
