Proposed Raised Table (Road Hump) Bawnmore Road/Montague Road, Rugby. Proposed 75mm Raised Table (Road Hump), with 2.0 metre On/Off Ramps, Ramps over the full width of road

Bawnmore Road (19m length)/Montague Road (12m length) junction.
