

## ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF CORPORATION STREET & NEWBOLD ROAD, RUGBY (South Bound Only)

Warwickshire County Council has made a Temporary Traffic Order closing Corporation Street & Newbold Road, Rugby (South Bound Only) from the junction with A426 Leicester Road to the junction with Warwick Street to vehicular traffic.

The closure is required to facilitate carriageway resurfacing & associated works.

The Order will commence on 16 March 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 26 March 2019.

## TEMPORARY CLOSURE OF WATTS LANE, RUGBY

## TEMPORARY CLOSURE OF HILLMORTON LANE, CLIFTON ON DUNSMORE, RUGBY & TEMPORARY SUSPENSION OF ONE WAY RESTRICTION ON THE SERVICE ROAD BETWEEN HILLMORTON LANE & LILBOURNE ROAD, CLIFTON ON DUNSMORE

Warwickshire County Council has made a Temporary Traffic Order closing Hillmorton Lane Clifton on Dunsmore, Rugby from its junction with the Service Road to its junction with Lilbourne Road, to vehicular traffic and suspending the One-Way traffic flow on the Service Road between Hillmorton Lane and Lilbourne Road.

The closure is required to safely facilitate urgent gas works.
